Rules and Guidelines:

MARKET DATES:

Kids Day at the Farmers Market will be held on July 15th, August 12th, and September 16th from 8 AM-12 PM.

MARKET SITE:

The site for the 2023 Noblesville Main Street Farmers Market will be Federal Hill Commons at the corner of Westfield Road (SR 32) and Cicero Road (SR 19).

What you CAN sell:

Items must be home/handmade by the child for this market! Some examples of past products include: baked goods, jewelry, candles, spices, slime etc. No items may be sold in violation of copyright laws.

What you CANNOT sell:

Potentially hazardous foods may NOT be sold. Products that are not home/handmade by the child are NOT permitted.

Registration to sell:

All Kids Day vendors must submit the Google form application. There is a \$10 vendor fee for Kids Day that will be collected on your day(s) of participation. We will accept cash, check and cards. All checks should be made out to "Noblesville Main Street". **Booth space is limited and all Kids Day vendors and applications will be handled on a first come first served basis.**

Space Reservations and Site Set Up:

You will only be provided with a 10x10 booth location. You must provide your own tent, tables and chairs. Card tables are allowed. **TENTS MAY NOT BE STAKED into the ground. Tents MUST be weighted.

Noblesville Main Street asks that all Kid's Day vendors be set up and ready for customers by 8:00 a.m. Vendors are not allowed to disassemble their booths before the market is closed at noon without prior permission of the Market Manager. The market must be vacated by 1:00 p.m. and all personal items, equipment and debris must be removed before leaving.

Tables or displays may be used, as long as all items for sale, used for display or owned by the vendor are contained within his/her designated space. Tables or displays must not be a hazard to the public or other vendors.

All Noblesville Farmers Market vendors, their representatives, and their families, while in the market must follow the Code of Conduct.

- 1. Treat market staff, volunteers, other vendors and customers with respect and understanding.
- 2. Notify Market Manager immediately of any unsafe conditions.
- 3. Resolve conflicts in an unobtrusive manner.
- 4. Rough, menacing, vulgar, profane or abusive language and/or sexual harassment will not be tolerated.
- 5. Practice safe behaviors always, including while driving on and off site, loading and unloading.
- 6. No vendor may be under the influence of illegal drugs or alcohol while participating at the market.
- 7. No vendor may smoke within the vending area.
- 8. All Kids Day vendors will leave their spaces clean, trash removed and in a condition suitable to the Market Manager and the property owner.
- 9. No political or religious campaigning.
- 10. No music shall be permitted that is not part of the weekly music or entertainment vendor or host designated by Noblesville Main Street.
- 11. Vendors may not publicly disparage other vendors, products or markets.
- 12. Customer questions regarding product should be answered factually and knowledgeably.
